Dear Journal Contributor:

Under U.S. copyright law, the transfer of copyright from the author must be confirmed in writing. To fulfill this requirement, all authors of the article must sign and return this publication agreement to the journal editor. If the article or creative work was prepared as a "work made for hire," your employer must also sign this agreement as an author. **The copyright transfer covers the written work but authors retain all rights to any photographs submitted with the article.**

PUBLICATION AGREEMENT

The undersigned author(s) submitted an article or creative portfolio entitled:

for publication in *Visual Communication Quarterly*, published by Taylor & Francis (T&F). The copyright for material in this journal is held in the name of the Visual Communication Division of the Association for Education in Journalism and Mass Communication (hereafter called the Division) and is administered by T&F.

Each author transfers all rights in the **WRITTEN** work, including copyright, exclusively to the Division. Each author retains the following rights:

1. All proprietary rights, other than copyright.
2. The right to make copies of all or part of the material for use by the author in teaching, provided these copies are not offered for sale.
3. The right to make copies of the work for circulation within an institution that employs the author.
4. The right to make oral presentations of the material.
5. The right to post the article on a public server prior to publication:
 - After submission and prior to acceptance, the author must also post a statement that the article has been submitted for publication in the journal but is not yet accepted.
 - After acceptance, the author must also post a statement that the article is accepted for publication in the journal, that it is copyrighted by the Division, and that readers must contact T&F for permission to reprint or use the material in any form.
6. The right to post all or part of the published article on a website created by the author, provided that a citation to the article and a notice for readers to contact T&F for permission to reprint is included.
7. The right to post the published article on a public server, provided that a citation to the article and a notice for readers to contact T&F for permission to use or reprint is included.
8. The right to use all or part of the published material in any book by the author, provided that a citation to the article is included and permission from T&F is obtained.

Each author agrees that all dissemination of material under the above conditions will include credit to the Division as the copyright holder.

Author(s) have submitted their own photographs with the above described article. Author(s) guarantee that they have full power and authority to copyright the photographs and to make this agreement. AUTHORS RETAIN ALL RIGHTS TO THESE PHOTOGRAPHS AND GRANT NONEXCLUSIVE WORLD RIGHTS IN ALL LANGUAGES to the Visual Communication Division of the Association for Education in Journalism and Mass Communication to use these photographs AS PART OF THE PRESENT ARTICLE ONLY and in future print and nonprint editions thereof.
